The undersigned also hereby grants permission to the Sarpy County Building Inspector and his lawfully appointed assistants for entry upon the premises described above for the purposes of monitoring the construction for which the building permit was granted. Furthermore, the undersigned further grants right of entry to the property to representatives of the Sarpy County Assessor's Office for the purpose of obtaining information necessary for the proper valuation of the premises for property tax purposes.

Representatives of Sarpy County as stated above are not required to give prior notice of entry on to said property. Entry by said public officials shall be exercised in a reasonable manner. The right to said entry shall terminate upon the building inspector giving final approval to the structure for which the permit was issued.

The undersigned represents that they are the individual or representatives of the entity with a right to enter said property and have the authority to grant the permission granted by this consent.
